Previous Minutes:

Motion to approve the Minutes of previous AGM held 7th August 2009 – moved David Morgan, seconded Paul Dumican - passed.

Amendments to Constitution:

Control of the meeting passed over to Rick Phillips the Public Officer.

Rick Phillips provided an explanation of the proposed amendments to the constitution.

The main issues being:

- Fatboys uniform **can only be purchased by current Fatboys members.**
